Dayna is an integral part of KJK's Student & Athlete Defense practice group, where she focuses on Higher Education, including Title IX, campus misconduct and other disciplinary matters.

Dayna provides advocacy and support for students involved in proceedings related to sexual assault, sexual harassment, and other forms of sexual misconduct primarily in Title IX proceedings. She uses her knowledge and skills gained during active law practice to help navigate students through the process. This includes providing information about the Title IX policy, reporting and complaint process, and alternatives to the Title IX process such as filing a criminal complaint or engaging in mediation or restorative justice. Dayna assists students with drafting their initial statements and preparing for hearings. She also provides supportive services to students during the hearing, fact finding phase and after the hearing. Dayna helps students weigh the potential impact of the process on their academic, social, and extracurricular life against their personal goals to help them make a decision that is best for them.

For more than 20 years, Dayna has advocated for, advised, mentored, educated and supported collegiate women in both public and private college/university settings. She has served in a volunteer capacity with her sorority as a National Chapter Advisor, Membership Specialist, College Chapter Director, Membership Advisor, Risk Prevention and Education Advisor and Standards Advisor at numerous campuses throughout Ohio including Bowling Green State University, Kent State University, Ohio University, Ohio Wesleyan University, The University of Akron, and Wright State University. As an advisor, she successfully worked with colleges, universities and collegiate women to investigate and mediate more than 20 disciplinary and misconduct matters.

Dayna has also created, facilitated and presented educational workshops and programs for collegiate women on both a state and regional level focusing on membership recruitment/retention, risk prevention and judicial procedures.

Prior to joining KJK, Dayna practiced law from 2006-2014 and represented clients in toxic tort and insurance defense matters. She also volunteered as a Summit County Court Appointed Special Advocate for 5 years where she was appointed by a judge to be a social justice advocate for abused and neglected children.
